### PAYMENT

If you decided to register for an option without a flight, but would like to upgrade later, you will be able to do so.

### CANCELLATIONS/REFUNDS

\$199 registration fee is non-refundable. This amount will be deducted from the total tuition payment. Program tuition paid is non-refundable after July 1<sup>st</sup>, 2023.
